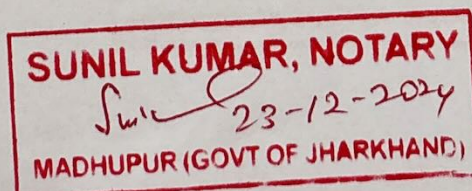
1. That I am the person named as the President of the proposed Society named “**Madhusthali Institute of Teacher Training Alumni Association**”.
